REPORT ON CORPORATE GOVERNANCE YEAR 2025

- Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020, issued by the Minister of Finance, providing guidance on information disclosure in the securities market;
- Pursuant to the Consolidated financial statements for Q1 2025 of Xuan Mai Investment and Construction Joint Stock Company, prepared on April 30, 2025.

Xuan Mai Investment and Construction Joint Stock Company provides the following explanations regarding certain contents in the Consolidated financial statements:

The after-tax profit in the reporting period incurred a loss, changing by 10% or more compared to the same period of the previous year:

The after-tax profit for Q1 2025 was VND (8.1) billion, compared to VND (5.5) billion in the same period of the previous year, representing a decrease of VND 2.6 billion, equivalent to a 47.8% reduction. The reasons for this decrease are as follows:

- (i) Net revenue in Q1 2025 decreased by VND 210.6 billion, equivalent to a 44.4% decline compared to Q1 2024, leading to a gross profit decrease of VND 17.3 billion compared to the same period in 2024.
- (ii) Financial expenses decreased by VND 9.1 billion, equivalent to a 38.8% reduction compared to the same period in 2024.
- (iii) Administrative expenses decreased by VND 4.1 billion, equivalent to a 19.2% reduction compared to the same period in 2024.

These factors combined resulted in a VND 3.4 billion decrease in after-tax profit compared to the same period of the previous year.

The above is the explanatory statement regarding certain contents in the Consolidated financial statements for Q1 2025 of Xuan Mai Investment and Construction Joint Stock Company.
