## REPORT ON CORPORATE GOVERNANCE YEAR 2025

- Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020, issued by the Minister of Finance, providing guidance on information disclosure in the securities market;
  - Pursuant to the Consolidated financial statements for Q2 2025 of Xuan Mai Investment and Construction Joint Stock Company, prepared on July 30, 2025.

Xuan Mai Investment and Construction Joint Stock Company provides the following explanations regarding certain contents in the Consolidated financial Statements:

The after-tax profit changed by 10% or more compared to the same period of the previous year:

The after-tax profit for Q2 2025 was VND 14.7 billion, compared to VND 8.2 billion in the same period of the previous year, representing a increase of VND 6.5 billion, equivalent to an 79.6% decline. The reasons for this increase are as follows:

- (i) Net revenue in Q2 2025 increased by VND 63.1 billion, equivalent to a 12.5% reduction compared to the same period in 2024.
- (ii) Financial income decreased by VND 18.8 billion, equivalent to a 79.2% reduction compared to the same period in 2024.
- (iii) Financial expenses decreased by VND 6.2 billion, equivalent to a 28.3% reduction compared to the same period in 2024.
- (iv) Administrative expenses decreased by VND 21.4 billion, equivalent to a 58.9% reduction compared to the same period in 2024.

These factors combined resulted in a VND 6.5 billion increase in after-tax profit compared to the same period of the previous year.

The above is the explanatory statement regarding certain contents in the Consolidated financial statements for Q2 2025 of Xuan Mai Investment and Construction Joint Stock Company.
