REPORT ON CORPORATE GOVERNANCE YEAR 2025

- Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020, issued by the Minister of Finance, providing guidance on information disclosure in the securities market;

- Pursuant to the separate financial statements for Q2 2025 of Xuan Mai Investment and

Construction Joint Stock Company, prepared on July 30, 2025.

Xuan Mai Investment and Construction Joint Stock Company provides the following explanations regarding certain contents in the separate financial:

The after-tax profit in the reporting period changing by 10% or more compared to the same

period of the previous year:

The after-tax profit for Q2 2025 was VND 10.2 billion, compared to VND 4.7 billion in the same period of the previous year, representing an increase VND 5.5 billion, equivalent to a 118.6% increase. The main reasons for the increased compared to the same period last year are as follows:

- (i) Net revenue in Q2 2025 increased by VND 112.7 billion, equivalent to a 24.4% compared to the same period in 2024.
- (ii) Financial income decreased by VND 18.9 billion, equivalent to a 80.3% reduction compared to the same period in 2024.
- (iii) Financial expenses decreased by VND 35.8 billion, equivalent to a 80.9% reduction compared to the same period in 2024.
- (iv) Administrative expenses decreased by VND 10.2 billion, equivalent to a 73.7% reduction compared to the same period in 2024.

These factors combined resulted in a VND 5.5 billion increase compared to the same period of the previous year.
